<b>Description</b>	Pasukhas Group Berhad ("PGB" or "the Company") - Update on the litigation between Emerald Capital (Ipoh) Sdn Bhd ("the Plaintiff") against Pasukhas Sdn Bhd ("the Defendant") (Federal Court Appeal No. W-02(C)A-2238-11/2017 & W-02(C)A-2239-11/2017)

We refer to the Company's announcements made on 28 June 2017, 2 August 2017, 5 October 2017 and 28 May 2018 in respect of the decision on the adjudication proceedings by PSB against Emerald via written Adjudication Decision dated 24 June 2017 from the Adjudicator and the dismissed of the Plaintiff's appeal to set aside the adjudication decision on 23 May 2018. *The terms herein shall bear the same meaning as defined in those announcements.*

The Board of Directors of PGB had on 29 June 2018 received an update from its solicitors, Messrs Kheng Hoe that the Plaintiff had filed an application for leave to the Federal Court on 21 June 2018 under Section 96 Court of Judicature Act 1964 and Order 55 and 107 Rules of Federal Court 1995 against the whole decision of the Court of Appeal given on 23 May 2018 in dismissing the Plaintiff's appeal against the decision of the High Court at Kuala Lumpur given on 4 October 2017 that allowed in part only the Plaintiff's application to set aside the entire adjudication decision dated 24 June 2017 pursuant to Section 15(b) and 15(d) of Construction Industry Payment and Adjudication Act 2012 ("CIPAA 2012").

The Plaintiff had also filed another application for leave to the Federal Court on 21 June 2018 under Section 96 Court of Judicature Act 1964 and Order 55 and 107 Rules of Federal Court 1995 against the whole decision of the Court of Appeal given on 23 May 2018 which upheld the High Court decision dated 4 October 2017 which allowed the Defendant's application to enforce the adjudication award dated 24 June 2017 under Section 28 of CIPAA 2012.

PGB will be seeking legal advice from its solicitors on this matter and will make further announcements on any material development on this matter from time to time.
