The Board of Directors of PGB wishes to announce that Pasukhas Sdn Bhd ("the Defendant"), a wholly-owned subsidiary of the Company, had on 8 September 2017 received a sealed Writ of Summons and Statement of Claim dated 23 August 2017 from the solicitors acting for Telekom Malaysia Berhad ("the Plaintiff").

Pursuant to the Statement of Claim, the Plaintiff is claiming, among others, the following:-

1. A total sum of RM698,342.98;
2. Interest at the rate of 5% per annum on the sum of RM698,942.98 from 25 August 2016 until the judgement date;
3. Interest at the rate of 5% per annum on the sum of RM698,942.98 from the judgement date until the date for case settlement;
4. Cost; and
5. Any other or further relief(s) that the Court shall deem fit.

The Company will be consulting its solicitors with regard to the Writ and Claim and will make further announcement from time to time in respect of any material developments on this matter.
